<u>Meeting Goal</u> is to begin to develop a process of outreach and engagement to potential new partners and a process for tracking progress towards achieving SWA recommendations.

- Structure of committees and governance: do we need a different governance model (e.g. more working groups)?

4. SWA Implementation and Outreach - Tara

- Continued discussion about expanding membership to develop a complete list of potential partners or allies:
 - First Nations:
 - Participation of all 8 First Nations with traditional territory in the Thames River watershed
 - Metis
 - Other municipalities:
 - LTVCA / UTRCA are going to all municipalities to discuss the changes to CA Act and this could be the way to bring this to municipalities.
 - Chatham Kent environment officer
 - Town of Ingersoll staff were involved in some meetings in the past.
 - Region of Waterloo and Stratford were approached in the past and kept somewhat informed.

- City of London is willing to help engage other municipalities.
- Agricultural sector: important, especially given the amount of land in the watershed. There are many groups, so need to determine who and how to engage:
 - Thames River Phosphorus Reduction Collaborative, Ontario Federation of Agriculture, Christian Farmers Federation, National Farmers Union, Ontario Soil and Crop Improvement Association, Ecological Farmers Association.
 - Likely need a subcommittee to develop plan.
- Other Conservation Authorities:
 - SCRCA is working on a phosphorus reduction plan for the Sydenham River.
- Canada Ontario Lake Erie Action Plan (LEAP): may overlap with nutrient reductions initiatives and habitat management.
- Discussed examples of specific projects that could meet recommendations in the SWA and / or whether those projects include partners that could / should be brought into this group.

5. Outreach and engagement with the potential partners/allies:

- Develop process for outreach and engagement with the potential partners/allies to determine:
 - their needs and level of participation.
 - types of outreach and communications tools that can help to promote the SWA and engage / encourage participation in implementation activities.

6. Implementation of Partner Recommendations

- Determine what support partners need to implement SWA recommendations, including types of communication products (e.g., presentations, fact sheets, etc.), proposal writing, etc.
- Determine what tools should be developed for tracking progress towards list of actions/ recommendations from SWA. Some examples include:
 - A catalogue of projects and programs undertaken by partners that are organized by actions / recommendations (e.g. similar to 2018 nutrient reduction project catalogue: http://thamesriver.on.ca/nutrient-project-catalogue
 - Develop a process for linking to other reporting that committee members are involved with that are already compiling actions related to the SWA recommendations (e.g. LEAP implementation)
 - Develop a process for linking recommendations / implementation to other reports (e.g. Lake Erie LAMP annual reports)
 - A spreadsheet of actions/ recommendations from the SWA, as well as who is responsible and status updates, for each partner (see example below)
